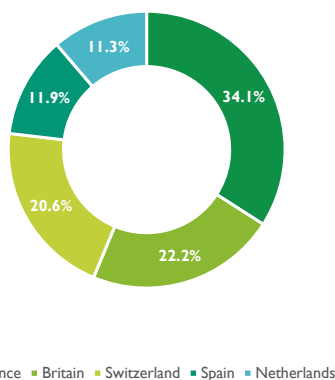

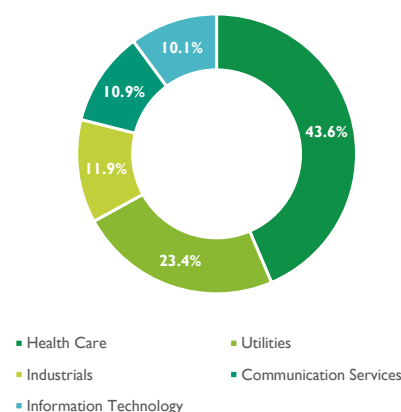
Market Review

Over the month, the European ESG Stocks as measured by the EURO STOXX 50 ESG Index TR (EUR) was up 8.50% underperforming the EURO STOXX 50 Index TR (EUR) by 61bps. Top performing countries in the ESG space were France and Germany while top performing sectors were Financials and Information Technology sectors. Market sentiment on European ESG stocks has been strong across the board, our indicator based on investor flows reveals a net inflows of approx. EUR1.1B last month on the asset class. At the end of last month and since the last expiry, 79% AXIOM Sustainability Premia investment has been profitable. At the country level, top contributors were France and Britain while main detractors were Netherlands and Switzerland. At the sector level, top contributors were Health Care and Utilities while main detractors were Communication Services and Information Technology. Top performing underlying stocks such as Sanofi a leading european pharmaceutical helped the fund performance while STMicroelectronics NV a developer and manufacturer of semiconductor declined during the month and was one of the main detractors.
